The mission of KRI is to provide state gaming regulators, legislatures, and public health experts with world-class research that will help reduce health inequities for those experiencing gambling disorder in the populations they serve, improve overall health of their citizens, and inform public health policy and gambling legislation.

At KRI, we believe that telehealth integration into existing treatment options as well as stand-alone telehealth systems that complement the care delivery continuum are the key to access for the future of treatment for individuals, families, and sub-populations that are at higher risk of experiencing gambling related harms due to age, socio-economic status, location in a rural community, race, ethnicity, religion, or gender.

Our goal is to advance the adoption of evidence-based telehealth solutions for gambling and gaming communities. Through research, we are currently developing evidence-based practice models for gambling with the intent of better understanding how telehealth, better access to assistance, and better access to the right tools, can impact high-quality mental health outcomes for those in treatment.

The 50x4 Vets research, led by Shane Kraus and Josh Grubbs, has been a beacon of hope and innovation. The clinical trials with naltrexone to study its impact on excessive gambling behavior

promise to open new therapeutic avenues for addressing gambling disorders.

Trent Lambert is the co-founder and CSO of Kindbridge - the country's foremost telehealth provider for behavioral addictions in the United States - providing unparalleled access to expert counseling and treatment for problem gambling, gaming, and other serious mental health conditions.

Driven by a desire to improve outcomes for active-duty military, veterans and first responders and their families, he is focused building strategic alliances between member groups, service and funding organizations to ensure that evidence based, high-quality outcomes are the highest priority from the first day an individual comes into care.

Trent also chairs the Board of Directors of Kindbridge Research Institute, a leading non-profit focused on improving military mental health through research, training, and treatment. Previously, Trent spent 10 years as a broker on the Chicago and Kansas City Boards of Trade, and afterword held posts overseas with Seaboard Overseas Trading Group for the better part of a decade while serving as their Vice President of Trading, and overseeing trading & risk management.

This year, we also strengthened our partnerships with academic institutions, healthcare providers, and community organizations. These collaborations have been instrumental in extending the reach and impact of our work.

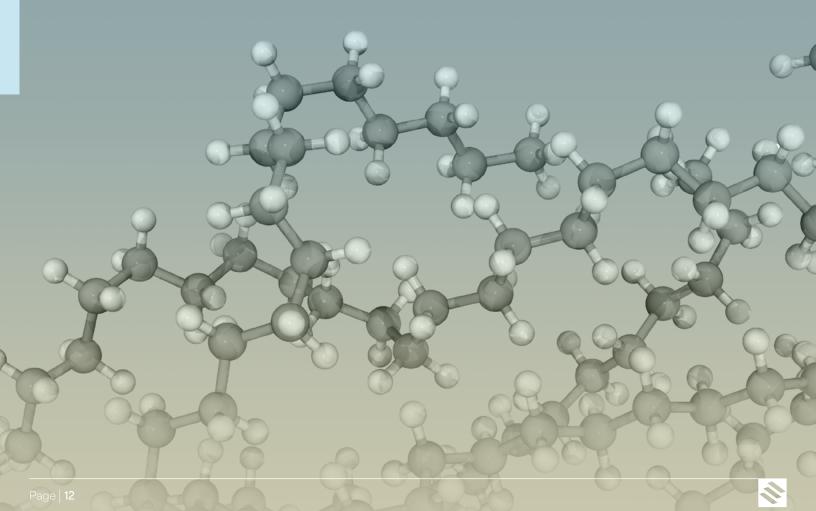

Dr. Tim Fong
MD, PSYCHIATRY, ADDICTION PSYCHIATRY

Dr. Fong is a Clinical Professor of Psychiatry at the Jane and Terry Semel Institute for Neuroscience and Human Behavior at UCLA.

Dr. Fong completed his undergraduate and medical school at Northwestern University in Chicago. He then came to UCLA and finished his residency in adult general psychiatry in 2002 and was the first accredited addiction psychiatry fellow at the UCLA Neuropsychiatric Institute (2002–2004).

He is the co-director of the UCLA Gambling Studies Program (UGSP). The purpose of this program is to examine the underlying causes and clinical characteristics of gambling disorder in order to develop effective, evidence-based treatment strategies.

Since 2009, he has been the director of the UCLA Addiction Psychiatry Fellowship, a one-year accredited program that provides clinical training in addiction psychiatry.

Finally, he is part of the faculty leadership of the UCLA Cannabis Research Initiative, a multidisciplinary effort to examine the full impact of cannabis on the body, mind and brain.



Dr. Stephanie Diez-Morel

Dr. Diez-Morel is founder of Reboot & Recover, a nonprofit organization dedicated to gaming disorder and other technology-based addictions. She is an assistant professor of graduate social work at Edinboro University and an invited member of the American Psychiatric Associations (APA) task force for Internet Gaming Disorder to discuss the inclusion and impact of Gaming Disorder in the Diagnostic and Statistical Manual of Mental Disorders (DSM).

Dr. Diez-Morel earned her Ph.D. from Florida International University where she was awarded the C-SALUD student scholar in Health Disparities Research Fellowship funded by the National Institutes of Health (NIH).

Through her work as a Licensed Clinical Social Worker (LCSW) and Master Certified Addiction Professional (MCAP), Dr. Diez- Morel worked within nonprofit community organizations and in community hospitals throughout Florida providing direct clinical services to children, families, and adults experiencing addiction.

Dr. Diez-Morel has received a number of awards and grants for her work on finding solutions to a balanced living in a technology driven world.



Dr. Jeremiah Weinstock

Dr. Jeremiah Weinstock is a professor in the Psychology department at Saint Louis University, focusing on addictive behaviors with an emphasis on gambling disorder and exercise as an intervention. As an academic clinical psychologist, he is expert in addictions treatment and prevention research with a specific emphasis on gambling disorder and the utility of exercise as an intervention strategy for all addictions.

He frequently conducts clinical trainings on gambling disorder treatment and on the development and implementation of contingency management for the treatment of substance use disorders.



# Lia Nower

Lia Nower, J.D., Ph.D., is a Professor and Director of the Center for Gambling Studies. A clinician and attorney who specializes in gambling disorder and behavioral addictions, she is also Director of the Addiction Counselor Training Certificate Program, a member of the leadership team of the Rutgers Addiction Research Center (RARC) and a research affiliate with the Sydney University Gambling Treatment Unit in the Brain and Mind Centre.

Dr. Nower's research focuses on online gambling and video gaming, sports wagering, psychometric measurement, the etiology and treatment of gambling and gaming disorder, and gambling-related policy issues.

She currently serves as a Regional Assistant Editor for International Gambling Studies and an Associate Editor for Addiction and Addictive Behaviors journals. Dr. Nower is a member of the Board of Directors of the National Council on Problem Gambling in Washington, D.C., where she also chairs the research committee and received the 2019 research award.

Dr. Nower has also co-authored several policy initiatives, including a model for self-exclusion programs and an industry framework for informed-choice and responsible gambling. She co-edited the book The Wiley-Blackwell Handbook of Disordered Gambling (2013).

#### **Project Aim**

The Kindbridge Research Institute's 50X4 Vets Project is an ambitious initiative aimed at significantly impacting veterans' mental health across the United States. The goal of the 50x4Vets program is to address the lack of research and increase the rate of research on treatment for veterans with gambling disorder by 50-times in the next 4 years.

#### **Progression**

Research Production: KRI's Principal Investigators (PIs) have recently published a comprehensive study on gambling treatment outcomes in military veterans, providing invaluable insights for the development of effective therapies. Currently, seven more papers are in progress, with one paper undergoing review. Overall, we are on course to achieve our objective of increasing research on treatment for gambling harm by fifty-fold by the end of 2024.

Veteran Treatment Database: Drs. Josh Grubbs and Heather Chapman have successfully compiled a database comprising over 1000 veterans who have undergone treatment for gambling disorder in Ohio over the past decade. This database now serves as a resource for extracting insights aimed at enhancing treatment for gambling disorder in military veterans.

Randomized Controlled Trials: Dr. Kraus and his team at UNLV have initiated two randomized controlled trials exploring novel treatment modalities for veterans with gambling disorder. These trials hold promise for furnishing valuable information on innovative treatments that could potentially revolutionize the management of gambling disorder within the VA medical system.

Trainings, Talks, and Conference Contributions: Drs. Kraus and Grubbs have made significant contributions to the two leading academic conferences in the field, delivering three talks and presenting five posters at the International Center for Responsible Gaming Conference, as well as three talks and four posters at the International Gaming Institute's conference, both held in Las Vegas. Additionally, the team has conducted fifteen educational webinars and keynote speeches focused on gambling disorders among military veterans, emphasizing clinical considerations and research findings.

#### **Project Aim**

The Miltary Research Associate Program (MRAP) is aimed at giving veterans access to critical resources, support and skills that aid further academic performance and pursuits. This innovative new program has the broad intention of helping veterans transition from military service to advanced training in mental health treatment and research.

#### **Progression**

The MRAP program is now in its third year, with six veterans having been through the program it up to this point. Two of them have already been accepted to pursue further education at esteemed institutions like John Hopkins and Yale universities. Through this program, participants acquire crucial skills such as writing, research, and data analysis, enabling them to engage with influencers and pursue advanced training and career opportunities that would otherwise be inaccessible to them. Additionally, participants have the chance to showcase their research findings to industry professionals at numerous academic conferences throughout the year.



Mark Lucia joined KRI in September 2021 to develop the MRAP initiative as the pilot member of the program. Since then, Mark has conducted and assisted with unique research projects on responsible gambling in the Department of Defense that have been presented at conferences across the U.S. and Canada. Mark has published research in peer-reviewed journals with the MRAP team and its KRI advisors. As a Military Research Associate, with KRI's assistance, Mark was accepted into several of his top choice universities, including Johns Hopkins University, Boston University, Columbia University, and George Washington University. He ultimately enrolled in a dual Master's in Public Health and Business Administration program at Johns Hopkins and is entering his final semester. Following graduation, Mark will work as a Pathways Operations Manager and continue working on gambling initiatives. His interests lie in organizational management, strategy, operations, and data analytics.

### KRI Grants - Colorado

In 2023, Kindbridge Research Institute received grants from the Colorado Department of Revenue Division of Gaming to support research initiatives focused on gambling addiction and mental health. These grants enable the institute to conduct comprehensive studies, develop innovative approaches to addiction treatment and prevention and deliver programs within the state. Through collaborations with experts in the field, Kindbridge Research Institute aims to enhance treatment outcomes, address the unique needs of individuals struggling with addiction with a particular focus on veterans and athletes, and contribute valuable insights to inform public policy and community-based interventions in Colorado.

# Strategic Assessment Program

Kindbridge Research Institute (KRI) completed a state-wide research project that studied gaming and gambling addictions within Colorado. A comprehensive analysis of the state's mental health treatment disparities in relation to Gambling Disorder (GD) was completed through the analysis of data collected, our objective was to create a strategic plan and framework for Gambling Disorder treatment across the state.

All data sets were mapped into a Geographic Information System (GIS) and made available in an interactive tool that enables the Colorado Gaming Commission and the Colorado Office of Civil and Forensic Mental Health to have a comprehensive picture of where the most at-risk populations are across the state.

The delivery of the data set, GIS, 5-year Strategic Plan and Implementation Roadmap is now complete and the GIS can be found on our website.

# Athlete Well-Being Program

Kindbridge Research Institute created the Athlete Wellbeing Program for the State of Colorado in coordination with Sport Radar. This program was designed to be a platform for the following:

- Education: Providing self-guided learning modules for anti-match fixing, social media integrity, and athlete well-being.
- Reporting: Providing a confidential service for reporting abuse or harassment by the Sports Betting community. The athletes remain entirely anonymous.
- Investigation: Once an athlete reports an abuse incident, authorities will be notified and take necessary action against perpetrators of harassment.
- Care: Athletes receive convenient access to mental health assessment tools, educational resources, or licenced counsellors through a telehealth app.



#### **Veterans Initiatives**

In partnership with the State of Colorado, KRI will delivered three programs that provided active military personnel and veterans with access to addiction therapy, peer support, post-secondary fellowships and career training as well as gambling awareness training at Colorado's ROTC schools.

Free mental health care for veterans, active-duty personnel and family members - This program was the first-of-its-kind and was designed to provide treatment for both family members and individuals who were living with a gaming or gambling behavioral addiction. Veterans and their families also had access to peer support sessions and virtual treatment with a licenced clinical counselors.

Colorado Military Research Fellowship - The Colorado Military Research Fellowship was a unique program that gave veterans in Colorado the opportunity to transition their careers through mental health research training in an academic environment. Two participants were selected to join the program received specialist training in research methods from the KRI team. They were also able to present some of their research at an academic conference and will be completing a webinar showcasing some of their work and training throughout the year.

The ROTC Education Program was another first-of-its-kind program which endeavored to educate and train Colorado-based reserve officers and corps members about gaming and gambling addictions. The program provided Reserve Officers Training Corps (ROTC) members with a fundamental understanding of gambling, problem gambling, gambling disorder, responsible gambling, co-morbid disorders, and problem gambling treatment through live in-person training as well as a self-directed online curriculum.
